 - President – four or six-year commitment
 - Vice President – two-year term
 - Governor-at-Large – two-year term (three open seats)
 - Regional Governor – two-year term (Regions B, C, D, F)
 - Regional Governor F (vacant) – one-year term
 - Governor for Part-Time – two-year term (Northern Region)
 - Governor for Retired Faculty – two-year term

Legislation

- [AB 2707 \(Fong\)](#) FACCC Sponsored
Community colleges: student housing: study.
Requests the LAO to conduct a study evaluating the age demographics of housing-insecure community college students to identify the issues and unique barriers that community college students 25 years of age and older face in securing housing.
- [AB 2370 \(Cervantes\)](#) FACCC Sponsored
Community colleges: faculty: artificial intelligence.
Would prohibit artificial intelligence from being used to replace community college faculty for purposes of providing academic instruction to, and regular interaction with, students in a course of instruction, and would authorize artificial intelligence to only be used as a peripheral tool to support faculty in carrying out those tasks for uses such as course development, assessment, and tutoring.

- [AB 2033 \(Reyes\)](#) FACCC Co-Sponsored with SSCCC
Community colleges: electronic benefits transfer cards.
Co-Sponsor: Student Senate for California Community Colleges (SSCCC). Every California Community College campus must have at least one convenience or grocery store that accepts EBT cards, as outlined in the legislation.
