# HISTORY OF "ADULT ED" IN CA

• 1856-San Francisco Board of Ed establishes first adult school – "Centers for Americanization"

• Early 1900's-School districts legally entitled to operate two programs for adults:

- Adult schools immigrant ed, basic skills, job skills
- ${\rm \circ}$  Junior colleges  $1^{\rm st}$  two years of postsecondary ed to high school graduates

• 1921 – Junior colleges formed own local boards apart from school districts

#### HISTORY OF ADULT ED IN CA

- 1941 Legislature authorized junior colleges to offer adult education
- By 1950's Over 300 adult schools operated in state, 50 of them run by junior colleges
- 1960's-1970's Adult education gets muddy, junior colleges become community colleges, CCC gets own Board of Governors

#### HISTORY OF ADULT ED IN CA

- 1991– Adult education was added to the mission of the CCC
- 1997 Court of Appeal rules that CCC districts do not need a mutual agreement to offer adult education since it is part of CCC mission
- 2009 Adult education funding was made flexible for school districts (but not for CCC), which was extended through 2014-2015.

- Title 5 Section 58160 authorizes eligibility for state apportionment for the following noncredit instruction areas:
  - A) ESL
  - B) Immigrant Education
  - C) Elementary and Secondary Basic Skills
  - D) Health and Safety
  - E) Substantial Disabilities
  - F) Parenting
  - G) Home Economics
  - H) Courses for Older Adults
  - I) Short Term Vocational
  - J) Workforce Preparation

# PROPOSED REDUCTIONS TO NONCREDIT AREAS

- LAO Recommendations, Governor's Trailer Bill and SB173 (Liu) are all proposing to reduce the allowable noncredit instruction areas by removing:
  - Courses for Older Adults
  - Parenting
  - Health and Safety
  - Home Economics

• ASCCC Resolution 13.01 (Sp 2013) : Support for Local Control in Noncredit Instruction Areas

# PROPOSED CHANGES TO BASIC SKILLS

- The LAO Recommendations also propose the following changes to CCC basic skills instruction:
  - English/ESL:
    - Restrict credit instruction to transfer-level coursework
    - All coursework below transfer-level would be offered on a noncredit basis
  - Math:
    - Restrict credit instruction to one-level below transfer or higher
    - All coursework two-levels below transfer or lower would be offered on a noncredit basis

• Noncredit as a division or department of the college

- Noncredit as a free standing school with separate accreditation
  - San Diego Continuing Education
  - North Orange County Community College District, School of Continuing Education

#### • Noncredit integration into Credit

• One ESL or Math department offering both noncredit and credit classes
