CREATING SPACE FOR COLLECTIVE VOICE: DIALOGUE AND DISCOURSE

THURSDAY, APRIL 20, 2017

Registration/Delegate Sign-in: Registration and Delegate Sign-in began at 7:30 a.m.

New Delegate Information and Resolution Writing: The Essentials: From 7:45 a.m. to 8:30 a.m. At this session, attendees were provided a comprehensive review of all aspects of the resolutions process. Also discussed were the requirements for delegates at the session, the process by which resolutions are brought forth at a plenary session, and the voting process used on the final day of plenary.

Candidate Information Session: From 8:00 a.m. to 8:30 a.m. attendees interested in running for a vacant position on the Executive Committee of the Academic Senate for California Community Colleges were invited to attend a candidate information session. Dan Crump, Chair of the Elections Committee, announced the vacant positions and informed potential candidates of the elections process and procedures.

FIRST GENERAL SESSION: From 8:30 a.m. to 9:45 a.m. Session participants attended the first general session. *Welcome and Call to Order:* President Julie Bruno called the 49th Spring Plenary Session of the Academic Senate for California Community Colleges to order at 8:30 a.m. and welcomed delegates and guests.

Adoption of the Procedures: Vice President John Stanskas presented the Academic Senate's Rules and Procedures and asked for their adoption. MSC: Adopt the Academic Senate's Rules and Procedures as presented.

Panel Discussion: Curriculum

Over the past three years, collaborative efforts involving the California Community Colleges Chancellor's Office, the ASCCC, and the Chief Instructional Officers' Board have led to changes in curriculum processes at the local, regional, and state level. The panel provided an overview of the changes taking place around the state, both at local colleges and at the Chancellor's Office, that will enable our colleges to be more efficient and streamlined in the approval and submission of curriculum.

Consultation Council Meeting: From 9:30 a.m. to 2:00 p.m., the Consultation Council met to discuss the California community college budget, governor's budget trailer bill, standalone course approval, articulated high school course, and legislation. The Consultation Council was established by AB1725 in 1988 as a mechanism for system input to the Chancellor on state-level issues, particularly those to come before the Board of Governors. The Council is comprised of 18 representatives of selected community college institutional and organizational groups.
