



Guided Pathways Report for ASCCC Executive Committee

1. The GPTF has a draft outline for a white paper on Placement Evaluation.
2. The GPTF will bring a proposal to the May Executive Committee Meeting for two “Status Reports” on COVID-19: one with a focus on students and one with a focus on faculty. We would like to work with the Student Senate. Alyssa from the RP Group mentioned that RP Group is also looking at doing something like this, so there may be room for collaboration with the RP Group.
3. The GPTF will share a survey at the May Executive Committee meeting. The survey is intended to assess Collegial Consultation taking place at colleges in regard to Guided Pathways design and implementation – Resolution F19 13.01 Collegial Consultation during Implementation of Guided Pathways
4. In response to ASCCC Resolutions the GPTF will make the following requests of the Chancellor’s Office Guided Pathways Advisory Committee (GPAC):
  - Request that the next SEA Program annual report required of local colleges (by end of calendar year) include the following question: “How does SEA Program funded activities contribute to local guided pathways implementation?”
  - Request that the next Scale of Adoption Assessment (SOAA) required of local colleges include the following question: “Does the Guided Pathways budget process include collegial consultation and input from Academic Senate and effective participation from other campus constituencies?”

**Resolution S19 5.02**

Resolved, That the Academic Senate for California Community Colleges work with system partners to ensure collegial consultation and transparency in local guided pathways budget development processes;

**Resolution F19 3.01**

Resolved, That the Academic Senate for California Community Colleges work with the California Community Colleges Chancellor’s Office to develop guidance for college districts on including in their annual Student Equity and Achievement (SEA) Program report an assessment of how SEA Program funded activities contribute to local guided pathways implementation; and
